Trustees began reviewing bills at 6:30 pm.

Mayor Skeet opened meeting at 7:00 pm.

Members present: Mayor Skeet, Trustees Graham, Peterson, Lauer and Bielec. Also present were Sergeant Jim Meier, Deputy Clerk Denise Beal and Court Clerk Pam Yasses.

Sergeant Meier updated the Board on conversation he had with Frank Ciacia of Genesee County Stop DWI regarding the recent suspension of the Village DWI funding. He said he was informed by Mr. Ciacia that the investigation by the State Police found that there was no fraud whatsoever on the Village's part. He did say there had been a procedural problem of not having designated specific officer's for DWI patrol in relation to the grant. Sergeant Meier said that in his conversation, Mr. Ciacia indicated that 2012 funding for the Village would be set aside until the dust settles, but that the Village would not be reimbursed for the balance of the 2011 grant funding, which amounts to almost \$3000.00. Sergeant Meier said Mr. Ciacia informed him that the funds had been suspended to show that the Genesee County Stop DWI was acting on the accusation they had received. Sergeant Meier did mention that the Investigating officer never came to or interviewed the source of the reports and that there was no written report that he knew of. He mentioned that the Village has been receiving the DWI grant for close to ten years. No procedures have been changed since the onset and there has never been a problem until the recent accusation was made.

Sergeant Meier asked Trustee Peterson why he made the accusation and Trustee Peterson refused to comment. Sergeant Meier said he felt if he was being accused of something it was his right to know what he was being accused of and asked Trustee Peterson to explain. Trustee Peterson refused to comment. Trustee Peterson was asked why he didn't go to the source of the reports or bring it to the Board and he refused to comment. Trustee Graham mentioned if Trustee Peterson felt he was acting for the benefit of Village taxpayer's he just cost them \$2000-\$3000.

Brief discussion also took place regarding an email Mayor Skeet had received from Trustee Peterson. Trustee Peterson questioned the Mayor sharing the email with the rest of the Board since it was addressed just to him and why Trustee Graham had answered the email instead of the Mayor. Mayor Skeet said he chose to share it with other Board members and they had every right to comment if they wished to.

Sergeant Meier mentioned he and Court Clerk Pam Yasses have been going over ticket counts on a monthly basis and they have been in agreement. He also mentioned that former officer Jim Delacy will be rejoining the force in mid January.

He also said he has been working with Verizon regarding problems they have been having with the air cards for the Police cars. He said they will be sending us three new air cards, but we will have to purchase two new hubs for the new cards.

Sergeant Meier said he was told the Police car that was budgeted for should be ready in February, so we can expect it around May. Trustee Lauer asked about the possibility of cameras on the traffic signal to catch those going right on red or running the red light. Sergeant Meier said cameras cannot be used in New York State for issuing traffic tickets because you have to be able to identify the driver to issue the ticket.

Sergeant Meier left meeting at 7:23pm and Teal Strollo joined the meeting at 7:23pm.

Ms. Strollo addressed the Board regarding the invisible fence issue that was discussed at a previous meeting and the letter she had been sent regarding repairs.

She said that she felt the work should be guaranteed for more than the three years mentioned in the letter. Other issues such as replacing a pine tree and handling some ponding that is occurring were discussed and it was agreed to have the Engineer take a look at the situation. Her original contract with the fence company will be looked at to check on the original footage of the fence as well.

Attorney Mark Boylan joined the meeting at 7:30 pm.

Ms. Strollo left the meeting at 7:35 pm.

Court Clerk Pam Yasses informed Board of cost and ordering details for pre-postage envelopes with return address. She had determined she mails out an average of 500 mailings per month. Since either prepayment or credit card payment is required, the Board determined ordering a 6 month supply at a time would make the most sense. She will be setting up an account for ordering.

Resolution to Introduce Local Law No. #1 of the year 2012

Village of Corfu, County of Genesee

A local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c

Section 1. Legislative Intent

It is the intent of this local law to allow the Village of Corfu to adopt a budget for the fiscal year commencing June 1, 2012 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

Section 3. Tax Levy Limit Override

The Board of Trustees of the Village of Corfu, County of Genesee, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2012 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this

local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.
