The Board was also reminded that beginning April 1, 2016 Court will be conducted on the first and fourth Mondays at 1:00 pm instead of the prior Wednesday evening Courts. Clerk relayed that the current Court assistant and security officer will be available for those times. It was mentioned that should the Court Security officer be unavailable for any reason, due to the time of the Court other officers could fill in.

Clerk informed the Board that the 5-year Shared Services agreement with surrounding municipalities was due for renewal this year and requested the Board renew the Resolution for the Shared Services Agreement. The Village has currently received copies of agreements from five other municipalities.

VILLAGE OF CORFU RESOLUTION FOR SHARED SERVICES AGREEMENT

A resolution authorizing the Mayor to sign an agreement on behalf of the Village of Corfu to directly contract with the Superintendent or persons holding similar public office in other municipalities who possess similar authorization for borrowing or lending of materials and supplies and the exchanging, leasing, renting of machinery and equipment, including the operators thereof, for the purpose of aiding the Superintendent/ Mayor in his/her duties.

WHEREAS, all municipalities, including the Village of Corfu, have the power and authority to contract for the purpose of renting, leasing, exchanging or borrowing of machinery and equipment, with or without operators, with other municipalities, and

WHEREAS, all municipalities, including the Village of Corfu, have the power and authority to borrow or lend materials and supplies to other municipalities, and

WHEREAS, it is hereby determined that the Village of Corfu and other municipalities have machinery and equipment which is not used at all times but lie idle during certain periods, and

WHEREAS, it is hereby determined that the Village of Corfu and other municipalities often have materials and supplies on hand which are not immediately needed, and

WHEREAS, it is hereby determined that by renting, borrowing, exchanging or leasing of machinery and equipment and the borrowing or lending of materials and supplies, the Village of Corfu and other municipalities may avoid the necessity of purchasing certain needed machinery and equipment and the

purchasing of or keeping a large inventory of certain extra materials and supplies, thereby saving the taxpayers money, and

WHEREAS, it is recognized and determined, from a practical working arrangement, that no program of renting, borrowing, exchanging or leasing of machinery and equipment or borrowing or lending of materials and supplies can be successful if each individual arrangement or agreement has to receive prior approval by the Village Board and the governing board of each of the municipalities which may be made on short notice and at times when governing boards are not in session, and

WHEREAS, it is incumbent on each municipality to design a simple method whereby materials and supplies, equipment and machinery, including the operators thereof, may be quickly obtained with a minimum of paperwork and inconvenience and with a swift approval process, and

WHEREAS, it is the intent of this Village Board to give the Mayor the authority to enter into renting, exchanging, borrowing and lending agreements with the persons serving in similar capacities in other municipalities without the necessity of obtaining approval of the Village Board to the making of each individual agreement, and

WHEREAS, a standard contract has been prepared which is expected to be adopted and placed into effect in other municipalities, which contract will grant the person holding the position comparable to Superintendent authority to make similar agreements, and

WHEREAS, it is hereby determined that it will be in the best interest of the Village of Corfu to be a party to such an agreement,

NOW THEREFORE BE IT RESOLVED that the Mayor of the Village of Corfu is hereby authorized to sign on behalf of the Village of Corfu the Shared Services Agreement which shall be effective on the date of signing, and be it further

RESOLVED, that the Mayor of the Village of Corfu is authorized and directed to file a copy of the Shared Services Agreement with the Village Clerk and the Superintendent/Mayor of each municipality/government agency within the County of Genesee and neighboring counties.
