Members Present: Mayor Bielec, Trustees Graham, Ianni, McMartin-Eck and Lauer. Also present were Mark Zimmerman from Village Planning Board, Code Enforcement Officer Craig Blake, Tom Dix of Potter Lumber, Village Maintenance employee Jesse Stocking and Mike Brown from New Wave.

Mayor Bielec opened the meeting 6:35 pm, followed by the Pledge of Allegiance.

Mark Zimmerman, co-chairman of the Village Planning Board, introduced himself. He informed the Board that the Planning Board recommends taking Dae Ju of the American Family Market and Mike Grant of Petals and Plants to court. He mentioned the Planning Board had consulted with Dave Saleh and feel that legal action needs to be taken on each. He added that the Planning Board is aware that the Village Board gave Mr. Grant an extension for clean-up, but the Planning Board is concerned regarding the safety of the interior due to concerns raised by the Fire Department during a call at that location, and feels the Code Enforcement Officer should be allowed to inspect the interior.

Mr. Zimmerman also said they would like to pursue action regarding the Union Hotel. Trustee Lauer said that the owner, Mr. Poodry, did give the Corfu Library Board a tour. It was also mentioned that Mr. Poodry has boarded up some windows, mowed the lawn and removed some of the brush around the building. Code Enforcement Officer Blake said he will contact Mr. Poodry regarding doing an inspection of the building.

The Board agreed that Attorney Grieco should be brought up to speed on the two properties first mentioned. Clerk was requested to send a copy of the two letters and list of violations on each to the Attorney.

Mark Zimmerman left the meeting at 6:45 pm.

Mike Brown of New Wave was introduced. It was explained that New Wave is the current energy supplier for the Village on National Grid Electric billing. Mr. Brown presented the Board with a savings report of the Village usage through the period of the contract. He indicated that the report shows savings of over \$3500 over market rates during the period of the contract. He did mention that the unusual winter did create more demand which leads to higher prices.

Mr. Brown mentioned that on the previous agreement the Village was on a variable rate, and he said that New Wave could offer the Village a fixed rate of 6.25% locked in on a new two-year agreement. The Board questioned our current status while they have the Village Attorney review the contract. Mr. Brown assured the Board that the Village would be on a month to month basis with no termination fee, but mentioned he can only guarantee the 6.25% rate until Friday of the current week. He agreed to send a PDF of the agreement to the office so it could be forwarded to the attorney.

Mike Brown left the meeting at 7:00 pm. Ron Witkop of Genesee Heights arrived at 7:00 pm.

Jesse Stocking requested to address the Board regarding part-time maintenance assistance. Trustee McMartin-Eck informed the Board that the Camden Addendum for part-time Maintenance would result in a savings of over \$1300 for the Village over going with an individual part-time person. Mayor Bielec pointed out that he does see the advantage of having the Camden employee who is at the Village plant on a regular basis, which means more accessibility and flexibility.

Some discussion took place regarding potential conflict of interest raised by Trustee Ianni. It was pointed out that the individual Camden employee would still be paid just for his regular 8 hour day by Camden. Trustee Graham also added that he planned to abstain from the vote due to his direct connection to Camden.

Motion was made by Mayor Bielec and seconded by Trustee McMartin Eck to approve the Camden Addendum to provide part-time maintenance to the Village as per the Agreement.
