



Village of Corfu Committee Meeting Minutes October 28, 2020

The Village of Corfu Board held its Monthly Committee Meeting at the Corfu Village Hall, 116 East Main Street on October 28, 2020 at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Trustee Doktor, Village Clerk, Jennifer Eck, and Camden Group Representative, Glenn Eck.

Mayor Sargent opened the Committee Meeting at 6:30 pm, followed by the Pledge to the Flag.

Planning Update:

- Trustee Reisdorf discussed with the Board that any applications received regarding Code and Zoning Enforcement should be sent immediately to Code Enforcement Officer, Brian Schollard
- Mayor Sargent stated the Village is in desperate need of planning Board members, Zoning board of Appeals members and Election Officials; Mike will put a message out on Facebook, and will also encourage residents on the next newsletter.
